## ORDER

- The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint 111. account with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.

The institution shall comply with the various other norms and standards IV. prescribed in the NCTE regulations, as amended from time to time.
